

## 9. PROMOTIONS

For the purpose of encouraging customers to try different telecommunication services, the Company may, with respect to any of its services or products in this Rate Schedule, offer a temporary waiver or partial waiver of any nonrecurring, usage or monthly rate. The Company may also offer incentives, benefits or gifts to customers to encourage the purchase or retention of any service or product. All promotional offers are subject to ofacility availability. Promotional offers do not constitute price changes.

**9. PROMOTIONS**

**BUSINESS QWEST CHOICE UNLIMITED PROMOTION**

During a promotional period from October 18, 2009 through January 15, 2010, the Company may offer an additional discount to new or existing business Qwest long distance customers who subscribe to the Qwest Choice Unlimited calling plan that includes both interstate and intrastate calling. Customers will be offered an \$8.75 discount per month for six months per line when the customer commits to a 2-year term agreement and, a \$7.50 discount per month for six months per line when the customer commits to a 3-year term agreement.

**IN ORDER TO BE ELIGIBLE FOR THIS OFFER, CUSTOMERS MUST BE A NEW OR EXISTING LONG DISTANCE CUSTOMER, A NEW OR EXISTING QWEST LOCAL SERVICES CUSTOMER WITH A QUALIFYING QWEST LOCAL EXCHANGE SERVICE PACKAGE AND A NEW OR EXISTING QWEST HIGH SPEED INTERNET SERVICE. THE ELIGIBLE QWEST LOCAL EXCHANGE SERVICE PACKAGES ARE:**

**THIS SERVICE IS PROVISIONED IN CONJUNCTION WITH THE INTERSTATE QWEST CHOICE UNLIMITED CALLING PLAN UNDER WHICH QWEST PROVIDES INTERSTATE LONG DISTANCE USAGE.
